

**GREENFIELD TOWNSHIP ORDINANCE 2019-1**

**AN ORDINANCE OF THE TOWNSHIP OF GREENFIELD, ERIE COUNTY, PENNSYLVANIA, PROVIDING FOR ENTERING INTO A FRANCHISE AGREEMENT WITH ARMSTRONG UTILITIES, INC. TO PROVIDE A CABLE TELEVISION AND TELECOMMUNICATIONS SYSTEM IN THE TOWNSHIP, PROVIDING CONDITIONS WITH REGARD TO INSTALLATION, CONSTRUCTION AND MAINTENANCE, AND ON USE AND OCCUPANCY OF STREETS, PROVIDING ADMINISTRATIVE MATTERS AND SETTING THE FRANCHISE FEE AT 5% OF GROSS ANNUAL RECEIPTS, PROVIDING FOR AN INITIAL TERM OF FIFTEEN (15) YEARS COMMENCING MARCH 15, 2019; ESTABLISHING INSURANCE AND OTHER REQUIREMENTS AND AUTHORIZING THE PROPER OFFICERS OF THE TOWNSHIP TO EXECUTE THE SAME.**

WHEREAS, under the provisions of the Township Code, the Township of Greenfield (the "Township") is empowered to regulate cable television and telecommunication companies operating within the Township, as well as the use of the streets and ways of the Township for the good of the Township residents; and

WHEREAS, the Township has determined that it is in the best interests of the Township's citizens for the Township to grant a non-exclusive cable franchise for the benefit of the citizens residing therein;

NOW, THEREFORE, this 26th day of February, 2019, the Board of Supervisors of the Township of Greenfield, in the County of Erie and Commonwealth of Pennsylvania hereby enacts and ordains as follows:

Section 1. Greenfield Township does hereby grant a non-exclusive franchise to Armstrong Utilities, Inc., to construct and operate a cable television and telecommunications system within Greenfield Township for an initial term of fifteen (15) years beginning March 15, 2019, under and subject to the terms and conditions specified in

the Franchise Agreement with Armstrong Utilities, Inc., attached hereto, made a part hereof and marked as Exhibit A.

Section 2. The Chairman of the Board of Supervisors is hereby authorized to execute the Franchise Agreement on behalf of the Township, with the Township Secretary to attest the execution of the same.

Section 3. This Ordinance shall become effective five (5) days after its adoption.
