1. Prices are for the 2024 season. Slip prices may be subject to rate adjustment in future years. All dock /slip space rent shall be payable in advance, upon submission of a signed agreement.
2. The North East Community Marina Authority (hereinafter THE AUTHORITY) shall retain the right to designate dock/slip space. Every effort shall be made to assign OCCUPANT the dock space of his/her choice; however, the rights of other occupants and the NECMA business judgement shall also be relevant factors in the assignment of dock/slip space.
3. OCCUPANT has read and agrees to NECMA’s Code of Conduct and agrees not to hold THE AUTHORITY, The Borough of North East, the Commonwealth of Pennsylvania, any associated employees, agents, successors and assigns liable for any loss caused by any delay in launching, winter storage, transporting or commissioning, which might be caused by weather or any other event beyond the control of the North East Community Marina Authority.
4. If OCCUPANT violates any of the terms and conditions contained in this agreement or those posted in the marina office, THE AUTHORITY shall have the option of terminating this agreement upon ten (10) days written notice to the OCCUPANT. OCCUPANT must remove his/her boat from the marina prior to the end of the 10-day period.

IN WITNESS WHEREOF, OCCUPANT has executed this Boat Dock/Slip Rental Agreement as evidence of his/her agreement and understanding of the conditions thereof.
